Dear Parents, Guardians and Staff of Trumbull Public Schools:

In accordance with Connecticut State Law regarding application of pesticides in schools, the Board of Education has adopted an Integrated Pest Management Plan (IPM). The goal of this plan is to reduce pesticide usage by preventing pest access to the building and eliminating food sources. Alternative methods of pest control will be applied when appropriate. These may include structural maintenance, sanitation, and mechanical or biological control.

All Trumbull Board of Education facilities are regularly inspected by a certified Pest Control Contractor (PCC). The PCC makes recommendations for corrective measures that are consistent with the Integrated Pest Management Plan. Pesticides will not be applied on a routine basis; however, they may be used as a tool to maintain pest population at or below an acceptable level. When a pesticide is used, the least toxic product deemed effective for the application will be used.

In accordance with State law, lawn care pesticides will not be used on Pre-K to 8th grade school grounds with the following exception:

- An emergency application as necessary to eliminate an immediate threat to human health.

Staff, parents or guardians that would like to be notified prior to the application of pesticide at their school may register at their school office to receive these advisories. Notices will be sent at least 24 hours prior to application, except when an emergency condition exists, and will include the:

1. name of the active ingredient of the pesticide being used;
2. target pest;
3. location of the application on the school property;
4. date of the application; and
5. name of the school administrator or designee who may be contacted for further information.

Emergency applications shall be made in accordance with the IPM plan and the instructions on the pesticide label. Restricted use pesticides will not be used.

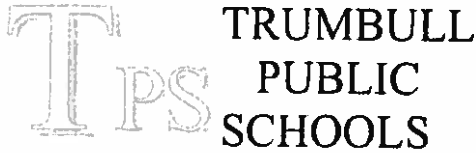
